Special Use Permit filed by Mid-MI Cat Rescue. SaraVicary, Director, is intending to operate feline specialty care housing / cat adoption / small store on M-99. Borucki moved / Johnson seconded to schedule a public hearing for the zoning change and a special use permit for Wednesday, September 11, 2013. Carried unanimously.

Reviewing previously issued Special Use Permits (Special Use Permits). Borucki will review minutes and provide a list to the Clerk. She will locate the pertinent SUPs and give those files to Borucki.

Zoning Maps. Foulds presented digital zoning map examples and reported that mixed use districts are not included since the Township does not have mixed use districts mapped.
