REPORTS:

Sheriff's Report:

Sergeant Campbell, Eaton County Sheriff's Office, gave a report on incidents occurring in the township; 153 calls over 21 days.

Planning Commission:

Trustee Blair reported: 1) the Planning Commission approved the appointment of officers at the January 13th meeting, voting to retain the same officers for 2016: Sandy Pray, Chairman; Fran Johnson, Vice-Chairman and Dan Blair, Secretary. 2) Set the Public Hearing, February 10, 2016, for a Special Use Permit application for 6394 Windsor Hwy. 3) Comprehensive Improvement Expenditure meetings set for February and March, as printed in the 2015 township newsletter.

Sewer Board:

Ralph Reznick, Village President, reported for the Sewer Board (in the absence of Trustee Slucter) that the Board had met on January 21st. Blue Water Village Complex will be billed for 1 REU per unit. The Sewer Board will meet in the future and develop a policy for REU's and have the policy in place by August 1 of 2016. A discussion was held about the Sewer Board Budget, with comments made by the Village Manager, Denise Parisian. After the discussion **Blair moved and Kandler seconded to adopt the 2016-2017 Sewer Board Budget. Carried: 6-0.**

Emergency Service Department:

Chief Miller reported his men worked hand in hand with Delhi Fire Department on a structure fire on Waverly Road; a button buck was rescued from breaking through the ice on the Grand River over off of Smith Road; Chief Miller passed out the Annual Report to all Board members; 28% of local businesses have attended the meetings about the Fire Codes, with a couple more meetings to be scheduled; 10 desk top computers and 2 lap tops have been purchased for the Emergency Services Dept. at a cost of \$12,739.06; the department is looking into Fire Inspection software and obtaining a couple of tablet computers; Braman moved and Myers seconded to hire Rebecha Hill as a full-firefighter trainee: Carried: 6-0.
