Slucter moved and Piper seconded to approve the Consent Agenda. Carried: 7-0.

Sheriff's Report: Deputy Holliday reported on incidents in the township.

Emergency Service Department: Chief Miller reported: 1) Rumsey moved and Slucter seconded to hire Luke Silver as a Paid On Call Trainee. Carried: 7-0. 2) Megan DeClercq, Kaleb Benjamin and Jeffrey Carrow have passed their national registry written and practical paramedic test.
