An Ordinance to amend Ordinance No. 42 to amend the maximum number for the commercial medical marihuana facility permits that may be issued within the Township.

THE CHARTER TOWNSHIP OF WINDSOR ORDAINS:

Section 1. Amendment to Ordinance Section 2.2. Section 2.2 of Ordinance No. 42 shall be amended to reflect the following number of permits available:

- 1. The number of Commercial Medical Marihuana Facility Permits in effect at any time shall not exceed the following maximums within the Township:
 - a. Grower Permits, Class A: 10
 - b. Grower Permits, Class B: 10
 - c. Grower Permits, Class C: 100
 - d. Processor Permits: 10
 - e. Safety Compliance Facility Permits: 5
 - f. Secure Transporter Permits: 3

The Township Board may review and amend these numbers by resolution annually or as it determines to be advisable.

Section 2. Effective Date. This Ordinance Amendment shall take effect immediately following publication or posting after final adoption by the Township Board.

Section 3. Repeal: All Ordinance or parts of Ordinances in conflict herewith are hereby repealed.
