<u>Emergency Services Department:</u> 1) Braman moved and Slucter seconded to accept the resignation of Allison Gromak and Chris Carrigan. Carried 7-0. 2) Braman moved and Myers seconded to hire Laura Curtis as a pool paramedic. Carried 7-0. 3) Chief Miller reported that one of the medics was placed on administrative leave.

Assessor: Getting everything ready for the Treasurer to be able to send out Summer Tax bills.

<u>Supervisor Report:</u> 1) Sent out several letters on property cleanup as well as started the process on the Azzawi house. 2) Received a call with concerns about pools not being taken care of and the mosquito issues it creates. 3) In keeping up with technology, we will be replacing two of the township's computers. Also, due to having fire and paramedic classes as well as other professional and organizational meetings in our meeting room, we are looking at purchasing a Smart Board. **Slucter moved and Piper seconded to approve the purchase of a 75" Smart Board. Carried 7-0.** 4) Looking at having a website built specific to Windsor Commerce Parkway (previously known as Lansing Road Corridor). 5) The closing on the sale of the Creyts Road (west side) property was completed last week.

#### **UNFINISHED BUSINESS**:

Braman moved and Rumsey seconded to recuse Trustee Slucter from voting on the adoption of the change of zoning for the Kamphuis' Billwood & Canal Road Properties. Carried 6-0.

Clerk Rumsey offered and Trustee Piper supported the final adoption on the rezoning of Parcel No. 080-010-100-003-00, 080-010-100-004-00 and 080-010-100-010-00, described as N ½ of the NW ¼, Except Highway in NW Corner; and Except the East 330 FT in Section 10 T3N, R3W, from PUD to M-1.

Ordinance to amend the zoning map adopted: 6-0.

Discussion was held on The Inter-Local Agreement for Local Police Service. The time spent in and out of township as well as itemized cost were examined. Slucter moved and Braman seconded to postpone a decision on the Inter-Local Agreement for Local Police Service until next regular meeting on June 12, 2018, to allow time for legal counsel to finish review. Carried 7-0.

More evaluation is needed on several of the drain issues. Slucter moved and Piper seconded to form a Drain Committee, consisting of Slucter, Piper and Myers. Carried 7-0.

#### **NEW BUSINESS:**

Legal counsel's review of the MABAS Agreement was discussed. How a MABAS division is formed and how it relates to the current Mutual Aid Agreements was explained. **Braman offered and Piper supported the Resolution to enter into the Interlocal Agreement creating a MABAS Division. The Windsor Township Board accepts the Planning Commission's recommendation and approves Bay County Holdings, LLC Special Use Permit, subject to the Planning Commission's conditions.
